## Foster Care

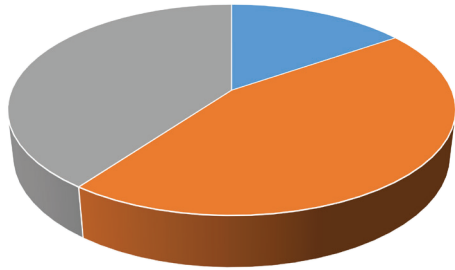

We provide psychiatric and intensive residential treatment with on-site schools, a **Therapeutic Foster Care** program, **Intensive In-Home Services**, and an **Independent Living** program for ages 18-21.

For more than 160 years, Bellewood Home for Children and Brooklawn Child & Family Services worked to nurture thousands of Kentucky's most vulnerable children. In 2012, these agencies combined to form **Uspiritus**, a non-profit organization helping children and families heal. We combined to provide the highest quality of care for the children and families across the Commonwealth. Our continuum of care allows children and families to move easily between services without disrupting established relationships.



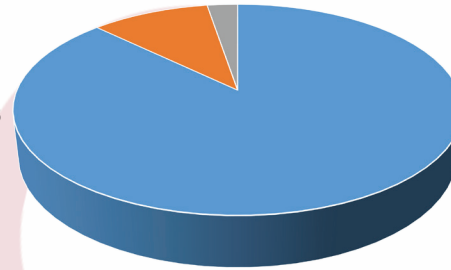

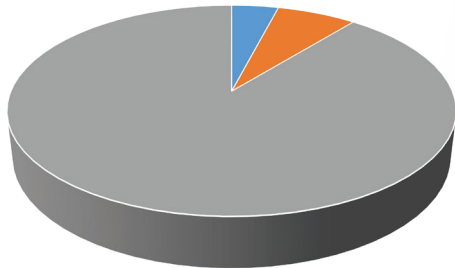

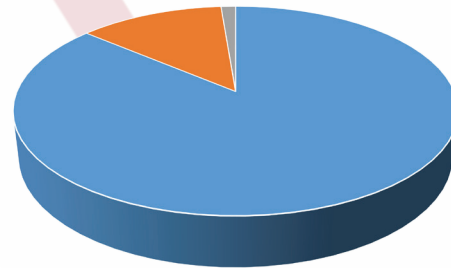

The employees of Accuserv have become regular visitors to Uspiritus this past year. They have "adopted" two cottages on Uspiritus' Brooklawn Campus and host a party once a month that includes some kind of game or crafts and usually special dinners. They bring in food from places like Qdoba and Mark's Feedstore. They provide them holiday treats such as Easter baskets and Christmas stockings, to ensure each of the approximately 26 kids in these cottages have a special day.

"They are that group that you can call and be willing to do whatever is needed," said Uspiritus Director of Community Engagement, Missy Fountain. "They truly care about the kids and the kids LOVE them!"

Approximately 10-20 Accuserv employees participate in a single event and as many as 28 have shown up to volunteer their time to spread joy to the children at Uspiritus.
